#### Overview of the webinars

The three-part webinar series is aimed at online retailers of all non-food consumer products, including electrical appliances, toys and consumer goods. It is relevant for all sellers of these products, whether they are sold new, repaired, refurbished or second-hand.

Even if you do not sell online, if you are involved in non-food consumer products, you will find this course helpful if you want to learn more about protecting your customers and your business.

Part one is an introduction and includes:

- the basics of product safety
- what are the risks to your business if you are not compliant
- why product safety is important
- what are the risks to your consumers

Part two of these webinars introduces [PAS 7050: Bringing safe products to the market. Code of practice](#) and [PAS 7100: Product recall and other corrective actions. Code of practice\\*](#).

[\*Both of these documents are free to download from the British Standards Institution website.]

PAS 7050 is a safety standard that supports businesses in bringing safe products to market, and provides suggestions and recommendations on what a 'product safety management plan' (PSMP) may look like. It provides a more proactive focus, with the aim of preventing unsafe products from reaching the market in the first place.
